# City Police Trainings



This past spring, staff from The Arc of Frederick County partnered with self-advocates to conduct trainings for the Frederick City Police Department on the inclusion of people with developmental disabilities in our local community.

The training offered to the Frederick City Police Department was interactive and covered topics such as the unique characteristics of specific disabilities, real life scenarios that included responding to the needs of people with disabilities, and lessons and discussions on the fundamental rights of people with developmental disabilities, among others. Each topic was presented by self-advocates and Arc staff.

The conclusion of each training included a panel discussion of local self-advocates. The panel shared their stories from their lives, answered questions from officers, and provided

tips as to how law enforcement can best support people with intellectual and developmental disabilities.

The trainings implemented the goals of the Governor's Commission for Effective Community Inclusion of Individuals with Intellectual and Developmental Disabilities. The Commission was established to develop and recommend policies, guidelines, and best practices for law enforcement and first responders to follow in situations involving people with intellectual and developmental disabilities. As part of the Commission, The Ethan Saylor Alliance requires that self-advocates take a central role in educating and training public service entities.

The Ethan Saylor Alliance was strengthened during the 2016 Maryland Legislative Session by the passing of the Ethan Saylor Alliance for Self–Advocates as Educators – Community Inclusion Training Oversight. The legislation, introduced by Delegate Carol Krimm, requires that training content and the monitoring of the implementation of objectives and curriculum be reviewed at least once every four years or more frequently if requested by the police training commission.

The Arc and local self-advocates look forward to partnering with the Frederick City Police Department to create inclusive communities in Frederick County.
