Legislative Wrap-Up

The Arc of Frederick County joined partners from across Maryland to take an active role in the 2015 Legislative Session. The busy session resulted in both positive and negative movement in terms of supporting people with intellectual and developmental disabilities and their families in Maryland.

Governor Hogan's budget fully funded the Transitioning Youth initiative. This funding will provide support to nearly 600 students with developmental disabilities as they transition from special education to the adult world. This funding is a critical piece of legislation that supports young adults to put the skills they have learned to practical use.

Sponsors Senator Ron Young and Delegate Carol Krimm led the way for a coalition of supporters to establish the Ethan Saylor Alliance for Self-Advocates as Educators in the Maryland Department of Disabilities. The purpose of the Alliance is to advance the community inclusion of individuals with developmental disabilities by having law enforcement receive training directly from people with intellectual and developmental disabilities.

The 2015 session also mandated that a task force be created on the Maryland Achieving a Better Life Experience (ABLE) Program. This task force is in follow up to Congress' passing of the ABLE Act. The ABLE Act allows individuals to open a tax free savings account that can be used to pay for disability-related expenses without counting toward asset caps that would compromise an individual's eligibility for federal programs. The recommendations of the task force are to be made to the Governor and the General Assembly on or before December 1, 2015.

Along with the success, there were also negative outcomes that will impact people with developmental disabilities and their families. The Governor's budget did not include any additional funds for the more than 8,000 people on the DDA Waiting List.

Historically, \$3M was provided for the highest category of need – Crisis Resolution. The 2015 legislature adopted the budget with \$3M for 125 people on the Crisis Resolution list; however the Governor failed to issue a Supplemental Budget to specifically authorize funds for this purpose. The Governor can use the funds for this need; or not. Unspent funds will revert to the General Fund. Given the tremendous need, The Arc has issued action alerts for members to request the Governor to designate these funds for people on the Crisis Resolution List.

National Institutes of Health Revises Research Priorities

In the first-ever update to The National Institutes of Health (NIH) Down Syndrome Research Plan, originally issued in 2007, is the addition of a new focus on Down Syndrome and Aging. The revision takes into account extensive input from the Down syndrome community, including researchers, constituency organizations, and individuals with Down Syndrome and their families. The plan is organized into five major research goals:

- Pathophysiology of Down Syndrome and Disease Progression
- Down Syndrome-Related Conditions: Screening, Diagnosis, and Functional Measures
- Treatment and Management
- Down Syndrome and Aging
- Research Infrastructure

Included within each of these goals are more specific objectives designed to advance these areas of research. "Because more people with Down Syndrome are living longer lives, new research questions are emerging," NIH says, "warranting a new goal, Down Syndrome and Aging, which, in conjunction with Treatment and Management, replaces the original category Living with Down Syndrome from the 2007 plan." The 2014 revised plan also provides an extensive bibliography of NIH-supported publications since 2007, grouped according to each of the research goals in the revised plan.
