## ART IN THE PARK BENCHES AUCTION

The benches silent auction bidding will be online and in-person. The minimum bid for a bench is \$400. The benches can be delivered within the Frederick, Maryland area (no stairs). Bids can be for a specific amount or an amount such as "up to \$950 going \$25 over the highest bid below that amount\*." Bids must be in \$25 increments. Bids will be in a "sealed envelope" rather than a typical auction format.

Specifics: Bidding ends at 5:00 PM on Saturday, May 5, 2018. In-person bids can only be made at The Arc at Market Street on Saturday, May 5 from 10:00 AM until 5:00 PM, which is when the benches are available for viewing. Bids online must be sent to Shauna Mulcahy at The Arc at [smulcahy@arcfc.org](mailto:smulcahy@arcfc.org) by 5:00 PM on Saturday, May 5. All email bids that are received will be acknowledged. Winners will be notified of winning bids on Monday, May 7 and Tuesday, May 8. All decisions as to winning bids/bidders will be made by The Arc of Frederick County at its sole discretion.
